- 1. The Government of India has applied for financing from the Asian Development Bank (ADB) towards the cost of Tamil Nadu Urban Flagship Investment Program—Tranche 3. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
- 2. The Chief Engineer, TWAD (Tamil Nadu Water Supply and Drainage) Board, Coimbatore ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of "(1) Construction of Sewage Treatment Plant of capacity 15.43 mld on DBO basis for UGSS to Added Areas namely Vadavalli and Veerakeralam Area Wards 16 to 19 (Zone V) of Coimbatore Corporation in Coimbatore District, and (2) Construction of Sewage Treatment Plant of capacity 19.49 mld on DBO basis for UGSS to Added Areas namely Kavundampalayam and Thudiyalur Area Wards 1(Part), 2 to 9 & 43(Part) (Zone VII)of Coimbatore Corporation in Coimbatore District (Rebidding) ("the Works"). Period of Completion is 24 months followed by 6 months Trial Run and including ten (10) years paid maintenance.
- 3. **National Competitive Bidding** will be conducted in accordance with ADB's <u>Single-Stage: Two Envelope</u>bidding procedure and is open to all bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications should participate in this bidding;
 - Minimum average annual turnover of INR 108.94 Crore, calculated as total certified received payments for contracts in processor completed, within the last three (3) years.

- HasFinancial resources, less its financial obligations for its current contract commitments defined, meet or exceed the total requirement for the Subject Contract of INR 6.83 Crore.
- Participation in at least one (1) contract that has been successfully or substantially completed within the last five (5) years and that is similar to the proposed contract, where the value of the Bidder's participation exceeds INR 54.47 Crore. The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology, or other characteristics as described in Section 6 (Employer's Requirements).
- Meets other Personnel and Equipment requirements as stipulated in the Bidding Document.

- 6. A pre-bid meetingshall take place on **26 April 2023 at 11:00 Hours (IST)**at the address stated above.
- 7. To purchase the bidding documents in English language, eligible Bidders should:
 - Visit the Office of the Executive Engineer, TWAD Board, Sewerage Division, Kuniyamuthur at 26, Corporation Shopping Complex, Avinashi road, Coimbatore and pay a non-refundable fee of INR 1180 towards the cost of bidding document in the form of Bank Demand Draft in favor of the Executive Engineer, TWAD Board, Sewerage Division, Kuniyamuthur, Coimbatore.
 - In case of written request, the document will be sent by post/courier. Bidders who
 wish to receive the bidding document by post/courier shall have to pay an additional
 amount of INR 5000 for delivery within India or US\$ 250 for delivery outside India.
 The method of payment will be through Bank Demand Draft in favor of the Executive
 Engineer, TWAD Board, Sewerage Division, Kuniyamuthur, Coimbatore. No liability
 will be accepted for loss or late delivery.

 - Eligible bidders who download the bidding document from above website shall inform
 the Executive Engineer, TWAD Board, Sewerage Division, Kuniyamuthur,

 failing which the Executive Engineer, TWAD Board shall not be responsible if the
 bidder does not receive clarifications and amendments, if any.

- Together with a Bid Security as described in the Bidding Document.
- Electronic submission is not allowed.
- Technical bids will be opened on 18 May 2023, at 15:30 Hours (IST) in the presence of 9. Bidders' representatives who choose to attend, whereas the financial bids shall remain sealed and unopened and shall be placed locked. The financial bids of only technically responsible and qualified bidders shall be opened after technical bid evaluation, whereas, the financial bids of those bidders whose technical bids are not responsive and qualified shall be returned unopened after the contract is awarded.
