CHAIR PROFESSOR (GENERAL INSURANCE)

It is hereby announced that vacancy of Chair Professor (General Insurance) would arise at NIA on 3rd December 2024.

NIA invites nominations for Chair Professor (General Insurance) which is meant for an eminent person who is from General Insurance stream of PSUs. The indicated zone of consideration will be Existing or Retired General Manager level officers. The applicant shall not be more than 62 years of age as on 1st December 2024.

The Chair Professor shall be paid a fixed Basic Pay of Rs.2,05,600/- p.m. plus Dearness allowance and transportation allowance as per 7th Central Pay Commission PB-14.

The role of the Chair Professor, terms and conditions and the process to be followed are given in the *Annexure*.

The applications from candidates should reach NIA in the prescribed format (*Annexure 1*) on or before 22nd October 2024 upto 5.30 p.m.

1. NIA invites nominations for Chair Professor (General Insurance) which is meant for an eminent person who is from General Insurance stream of PSUs.

2. Eligibility:

- Existing or Retired General Manager level officers, not more than 62 years of age as of 1st December 2024.
- Must have an aptitude for Research
- 3. **Term of appointment:** The incumbent will be appointed initially for a period of two years on a contractual basis, which can be further extended after satisfactory review for a further period of one more year or upto 65 years of age, whichever is earlier.
- 4. **Pay**: The Chair Professor shall be paid a fixed Basic Pay of Rs.2,05,600/- p.m. plus Dearness allowance and transportation allowance as per 7th Central Pay Commission PB-14.
- 5. **Other** terms and conditions of appointment, like leave, PF, etc. will be as applicable to Chair Professors at NIA.
- 6. Unfurnished accommodation on the campus will be provided subject to rules of the Academy.
- 7. The **responsibilities** of Chair Professor may include the following:
 - Academic & Administrative leadership:
 - Oversight of the General Insurance faculty and work with faculty to design Management Development Programmes;
 - Lead research and consultancy activities;
 - Conduct & Coordinate MDP sessions;
 - Publish articles and research papers;
 - Maintain relations with insurers, intermediaries and other stakeholders in the insurance sector:
 - Review the PGDM curriculum and teach;
 - Conduct Seminars & Workshops;
 - Conduct Examinations for and on behalf of different organizations;
 - General Administration and committee work;
