- 1. National Insurance Academy (NIA) invites applications from officers working in the Public Sector General Insurance / Reinsurance Companies for the position of Chair Professor (General Insurance).
- The zone of consideration will be officers who are / have worked in the cadre of General Managers in the General Insurance / Reinsurance streams of PSUs.
- 3. As per decision of the Governing Board, NIA retired persons who are not more than 62 years of age on 01.02.2019 are eligible to apply.
- 4. The post is on contractual basis for a fixed term.
- 5. Initial tenure will be for a period of two years and extension can be considered at the discretion of NIA subject to satisfactory performance.
- 6. The responsibilities of the Chair Professor include the following:
 - Academic & Administrative leadership;
 - Oversight of the General Insurance faculty and work with faculty to design Management Development Programmes;
 - Lead research and consultancy activities;
 - Conduct & Coordinate MDP sessions;
 - Publish articles and research papers:
 - Maintain relations with insurers, intermediaries and other stakeholders in the insurance sector;
 - Review the PGDM curriculum and teach, if required;
 - Conduct Seminars & Workshops;
 - Conduct Examinations for and on behalf of different organizations;
 - General Administration and committee work;

7. Salary and allowances:

- As per scale of Professor of the Academy
- Provident Fund, LTC
- Unfurnished accommodation on the campus subject to rules of the Academy
- Leave and other benefits as applicable to Chair Professor.
